I acknowledge and agree as follows:

- 1) My completed Booking Form, together with the required non refundable deposit of \$50, must be received by The Road Less Travelled Ltd to confirm my place on the Tour Experience.
- 2) The full balance is payable by *14th August 2010*.

My booking may be considered cancelled if the full balance is not received by that time.

- 3) I am responsible for ensuring I am fit and healthy enough to participate in this trip. The Road Less Travelled Ltd reserves the right to insist on medical certification from my Medical Practitioner stating I am medically and physically fit for my chosen trip. If I suffer from heart, chest, muscular, neurological or respiratory disorders, severe asthma or high blood pressure, or other acute / chronic illness, I acknowledge I should seek qualified specialist medical advice before considering joining the trip.
 - 4) It may become necessary, due to weather, local conditions, politics or various other reasons, to make changes to tour itineraries. Such changes will always be at the sole discretion of The Road Less Travelled Ltd Tour Leader, and no refund will be considered in the event of such changes.
 - 5) The Road Less Travelled Ltd takes no responsibility for any flight delays or schedule changes at any stage throughout the trip. In the event of any such changes no refund will be considered and I must seek recompense through my own travel insurance.
